Proposed IMD Alpine Receivables Policies

Outstanding Head Tax

All USSA, Western Regional and Intermountain Division event head taxes are required to be paid within fourteen days after the completion of the event. Any organizer with outstanding head tax due at the time of the Intermountain Division Spring Meeting will not be eligible to bid on or host Intermountain Division events for the following season.

Division Projects and IMD Athletes attending WR races

Athletes withdrawing from IMD hosted projects with short notice, after budgets have been set and expenses fixed can impact the budget negatively. The project fees are based on attendance.

Proposal

Athletes accepting invitations to participate in IMD hosted projects are required to make payment in-full through the online registration system by the deadline. Should an athlete withdraw from IMD hosted project, a minimum of fourteen days notice is required to be eligible to receive a refund. The division may grant a full refund if an alternate is able to attend.

Athletes attending races, camps or projects via an IMD Quota spot, will pay IMD through their home club. IMD clubs who have a balance owed to IMD from a prior season are ineligible to vote on the ACC or during the IMD spring meeting.

Payments not received by the deadline will be assessed a \$50.00 late fee.

A convenience fee of 3% may be charged for electronic payments.

Date: August 23, 2017 Proposal: IMD ACC Reform

During our last IMD ACC meeting, the Executive Committee was tasked with putting forth a proposal for ACC reform. Currently, the IMD ACC consists of 22 members. The current IMD Policy is that a member club is entitled to have one vote on the ACC. There are more than 22 member clubs in IMD. If we continue to follow the rules that we have adhered to in the past, IMD could have an additional 5 or so members on the ACC. Within the 22 members 5 of those are appointed members.

Executive Committee Thoughts

The current structure of the ACC is getting unmanageable in size. In addition, there is some duplicity with more that 1 ACC member affiliated with the same club. Additionally, the voting is getting more polarized between the North and the South, simply because most of the new start up clubs are from the South.

Proposal

- IMD will take nominations for ACC members via email following the Labor Day weekend. Each IMD Club with 15 or more members will then receive a ballot with those nominations. Each Club is allowed to vote for 12 nominees for the ACC.
- The elected ACC members will consist of a minimum of 5 members from the North and 5 members from the South.
- Chairman's Appointed members are: BOD President, Alpine Officials Chairman, Athlete Representative, Development Committee Chairman and the Finance Committee Chairman.
- The YSL Committee will be a sub committee of the Development Committee
- A club may only have 1 voting member on the ACC. If there are two people affiliated with the same club, only 1 member may vote.
- In the event of a tie, the tie will be broken by the 5 member Executive Committee.
- Moving forward, nominations will be taken each spring with a ballot for the ACC being voted on at the Spring ACC Meeting.
- The ACC Chairman and Vice-Chairman are voted on by the ACC. The term for the Chairman and Vice-Chairman is a two year term. The ACC Chairman and Vice-Chairman cannot both be from the North or the South. They will rotate.
- The IMD ACC Chairman and Vice-Chairman will represent IMD on the Western Region ACC.
- The new ACC will consist of 12 members who will be voted in and 5 appointed members.
