This season all race workers must be checked against the Safe Sport "naughty list" in order to work races. It was suggested that Race Organizers get a volunteer to help monitor the volunteers. Attached is the link for the Quality Control System for Athlete's Safety at events. Please familiarize yourself with this document.

- In order to advance to another level in your AO Certifications, coaches and club administrators need to request updates from the IMD AO Chair. This does not happen automatically. Please be aware and help IMD move our Alpine Officials up through the pipeline.
- It is highly recommended that coaches who are going through the Level 100 coaching course, take an in-person Referee Clinic rather than obtaining it online. The pass percentage rate online is quite low and as of now the Referee Module is not available.
- If anyone is interested in teaching the Nov. 12th Timing and Calculations Clinic in Sun Valley, Steve Schowengerdt would gladly step aside so someone else may gain the experience.

Coaches Education Update- Carma is currently working on getting a Coach Developer Clinic in IMD along with Level 100, 200 and 300 coach's clinic.

Development Committee Proposals/Clarifications- Troy Price

- Troy is working with Craig Haaser, YSL Chairman and the YSL Committee to assign team assignments for the YSL races and to get a comprehensive email list.
- IMD Champs Qualification- We will score individual runs at each North and South qualifying event in order to qualify for IMD Champs. IMD will use 50% of the runs contested and add them together for an overall World Cup point total.
- North/South Seeding Clarification- Gender split races Run 1- Random draw Run 2- Reverse first run draw Run 3- Butterfly Run 4- Reverse butterfly
- Speed Camp Clarification

The U14 speed camp is open to first year U14's. 2nd year U14's cannot participate. IMD will arrange for lodging at the church camp outside of Fairfield. The ski area will be closed and parents will not be able to ski at Soldier while the camp is going on.

- Vertical Drop/Ski-Up Agreement Because the vertical drop requirement needs to stay with the youngest age group in a race, U10's will need to fill out a ski-up agreement if they qualify for IMD Champs.
- U16 access to Tri-Divisionals

The Development Committee feels the quotas and selections should remain the same as last season for athletes qualifying for Tri-Divisionals through the U16 qualifying series. U16's who declare at the beginning of the season that they would like to race in the U14 qualifying series rather than the U16 qualifying series can have access that way as well.

• Troy mentioned that Dave Kerwynn has been hired as the WR Coach and Heidi Voelker has been hired as the WR Administrator.

North Race at Tamarack- The McCall Winter Sports Club will be merging with the Tamarack Ski Team. Erik Fisher reported that the North race scheduled at Tamarack will be confirmed next week.
